

## **Background Information for Nonprofits**

A Federal tax exempt designation as a 501 (c) (3) from the IRS may make an organization eligible for certain benefits. The designation also comes with some important requirements. Although most federal tax-exempt organizations are nonprofit, establishing a nonprofit organization at the state level does not automatically grant the organization exemption from federal income tax. The information offered in this chart is only intended to provide general guidance. Anyone who wants to create a nonprofit corporation should consult an attorney.

IRS requirements vary depending on the amount of the charitable donation.
